1. Approval process

1.1 Approval process may take up to 30 days from date of submission.

2. Equipment deployment

2.1 Equipment must be deployed on the sites within 90 calendar days from date of approval. Thereafter, the space will become available for allocation to other applicants.

2.2 Equipment may only be deployed upon signing of the tariff sheet and agreement/addendum.

3. Tagging of equipment at sites

3.1 All equipment is required to be labelled with owner's logo. Failure to do so may result in equipment being removed from the site.

4. Payments and suspension of services

4.1 Failure to effect payment before the due date may result in request to remove equipment from the building and or removal of equipment by PowerCom.

4.2 All payments must be effected by electronic transfers only, to an account to be provided by PowerCom in writing in the contract.

4.3 No cheque payments will be acceptable.

5. Notice of Discontinuance
